



**Condor Campers**  
**Zero Liability Insurance**  
**Effective: 01 August 2023 – 31 May 2024**

**This is a separate zero liability insurance which has been purchased at an additional cost of \$450,000 CLP. This document is to be used in conjunction with the Rental Agreement Terms & Conditions.**

- 1.1. The Customer is fully liable for all costs resulting from damages/losses incurred as a result of the below, these are exempt from the zero liability insurance, and the customer will be charged accordingly.
- 1.2. Accident/fine whilst not respecting any traffic signs.
- 1.3. Accident/fine whilst driving over the speed limit
- 1.4. Accident by falling asleep at the wheel or fatigue
- 1.5. Accident/fine whilst driving under the influence of alcohol or drugs.
- 1.6. Theft whilst leaving the Vehicle with the ignition key inside while it is unoccupied.
- 1.7. Damages to door locks, door handles or windows in case of Vehicle break-ins
- 1.8. Damage to the Vehicle by:
  - a) Submersion in any type of water
  - b) Contact with salt water
  - c) Creek or river crossing
  - d) Driving through flooded or sandy areas
  - e) Beach or salt flat driving
- 1.9. Damage to the Vehicle by driving under an object lower than the height of the Vehicle
- 1.10. Damage/fines while using the Vehicle for any illegal purpose or in any race, rally or contest; or for the purpose of transporting and haulage of goods other than what might be reasonably expected of a leisure rental
- 1.11. Damage by using the Vehicle to tow any Vehicle or trailer
- 1.12. Damage/fines whilst using the Vehicle to carry passengers or property for hire or reward, carrying more persons than is permitted by any relevant authority or as detailed on [www.condorcampers.com](http://www.condorcampers.com) vehicle specification. All passengers must use a seat belt at all times.
- 1.13. Damage by using the Vehicle to carry volatile liquids, gases, explosives or other corrosive or inflammable material;
- 1.14. Damage by using the Vehicle to carry animals, excluding registered dogs.
- 1.15. Damage by using the Vehicle on unfit roads for the Vehicle.
- 1.16. Damage for starting or driving a Vehicle that has been involved in an accident, Damaged by rollover, water submersion or any other failure or inconvenience without previous and written permission from Condor Campers.
- 1.17. Any Damage/loss of personal items resultant from theft/fire or break-ins. Condor Campers does not offer any compensation for loss of any personal items.
- 1.18. Any Damage caused to the Vehicle due to the use of inappropriate snow chains
- 1.19. Any Damages caused by drivers not identified on this Rental Agreement and/or drivers who's license that has been cancelled or suspended and/or drivers who have a license that is classified as a learners or provisional license.
- 1.20. Any Damage costs associated with the incorrect use of fuel (fuel being petrol), this includes Bio/Eco Diesel which should not be used, water, other contamination of fuel or any liquid different from the appropriate fuel.
- 1.21. Damage to the interior of the Vehicle due to the use of candles or misuse of the camping cooker.
- 1.22. Damage to the Vehicle due to smoking inside. Smoking is strictly forbidden and a cleaning fee of 200,000 CLP will be charged along with any costs relating to interior damage as a result of smoking.
- 1.23. Any Damage/Theft of the rooftop tent will not be covered, customers are fully liable for the rooftop tent while hiring the Condor 4x4 Popup.
